Acuite has reviewed the long-term rating of '**ACUITE D' (read as ACUITE B)** and short term rating of '**ACUITE D' (read as ACUITE D)** on the Rs. 28.78 crore bank facilities of Servall Engineering Works Private Limited (SEWPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Incorporated in 1989, SEWPL is a Coimbatore-based company that took over the engineering division assets of 'Servall Engineering Industries Private Limited'. The latter was incorporated in 1975 and was engaged in the manufacture and export of paper manufacturing machines. Directors of Servall Engineering Works Private Limited are Shobana Shivaram Prasad, Alagappan Chandramouli

#### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
