SMERA has reviewed long-term rating of '**SMERA BB+**' (read as **SMERA BB plus**) and short term rating of '**SMERA A4+**' (read as '**SMERA A four plus**') on the Rs. 18.05 crore bank facilities of SONODYNE INTERNATIONAL PRIVATE LIMITED. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower

SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

About the Rated Entity

Sonodyne International Private Limited (SIPL), a Kolkata-based company established in 1970, by Mr Ashok Kumar Mukherjee manufactures professional audio systems, electronic power supplies and low frequency amplifiers at its facility at SEEPZ, Andheri (East), Mumbai.

For FY2014-15, SIPL reported profit after tax (PAT) of Rs.0.18 crore on total operating income of Rs.19.35 crore compared to PAT of Rs.0.39 crore on total operating income of Rs.17.66 crore in FY2013-14. For FY2014-15, the Sonodyne group reported PAT of Rs.1.16 crore on total operating income of Rs.37.12 crore compared to PAT of Rs.1.99 crore on total operating income of Rs.35.13 crore in FY2013-14.
