Acuité has reviewed long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 25.00 crore bank facilities of Durgamba Motors. This rating is now an indicative rating and is based on best available information.

The rating downgrade is in view of delays in servicing the debt obligation.

Durgamba Motors (DM) was established in the year 1975 by Mr. Sadananda Chatra and Mr. Krishnananda Chatra as partnership firm. The firm engaged in passenger transportation business and luggage services in the state of Karnataka.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
