Acuité has reviewed the long-term rating of '**ACUITE D**' (**read as ACUITE D**) on the Rs. 25.00 crore bank facilities of Durgamba Motors (DM). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Karnataka-based DM was established in the year 1975 by Mr. Sadananda Chatra and Mr. Krishnananda Chatra as partnership firm. The firm engaged in passenger transportation business and luggage services.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
