Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs. 25.00 crore bank facilities of Durgamba Motors (DM). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Karnataka-based Durgamba Motors was established in the year 1975 by Mr. Sadananda Chatra and Mr. Krishnananda Chatra as partnership firm. The firm engaged in passenger transportation business and luggage services.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
