Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs.14.69 crore bank facilities of Wazir Singh Yarns Private Limited (WSPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Amritsar based, Wazir Singh Yarns Private Limited (WSPL) was established in 2008. It undertakes manufacturing and trading of nonwoven fabric and home textiles. Mr. Anudeep Singh and Mr. Dalbir Kaur are the current directors of the company.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
