Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs.19.50 crore bank facilities of Advaita Homes. This rating is now an indicative rating and is based on best available information.

AH, established in 2011, is the real estate arm of the BMR group. The group has already completed three projects in Chennai and is currently constructing a residential project at kelambakkam in Chennai (Tamil Nadu).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
