

### Rating Rationale

Acuité has downgraded its long term rating to 'ACUITE D' (read as ACUITE D)' from 'ACUITE B' (read as ACUITE B) and the short term rating to 'ACUITE D' (read as ACUITE D)' from 'ACUITE A4' (read as ACUITE A four) on the Rs.5.00 crore bank facilities of Sudalagunta Agro Mills Limited. The rating continues to be flagged as "Issue Not Cooperating" and is on account of information risk. The downgrade is on the account of the suit filed against the company as mentioned in the defaulter list published by CIBIL.

#### **About the Company**

Sudalagunta Agro Mills Limited, established in 2007 is a Tirupati-based company promoted by Mr. Jayaram Chowdary, Mr. Krishna Kumar and Mrs. Prameela, engaged in the milling of whole-wheat flour (aata), wheat flour (maida) and semolina (suji)

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date. This rating continues to be flagged as "Issuer notcooperating", in line with prevailing SEBI regulations and Acuité's policies.

The rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower).
