Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 8.00 crore bank facilities of TM Subramaniam and Co on account of information risk. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Chennai based, TM Subramaniam and Co a proprietorship concern, was established in 1973 by Mr. T.M. Subramaniam and converted to a partnership firm in 2013. He is joined by his sons, Mr. T.M.S Sivakumar, Mr. Shakthi Sivakumar and Mr. T.S.S Sharan Kumar as partners. The firm undertakes civil construction projects for Government organisations.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
