Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) and the short-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs.8.06 crore bank facilities of Bose Foot Fashions Private Limited (BFPL). The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

Bose Foot Fashions Private Limited (BFPL) is a Noida based company incorporated in 2010 by Mr. S. Bose and Mrs. Sanchita Bose is engaged in the manufacture and export of leather footwear. The operations of the company were started in 2013 by taking over the running business of Bose Creations & Export; a proprietorship concern of Mr. S. Bose.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
