**Rating Rationale**

Acuité has downgraded the long-term rating to '**ACUITE BBB**' (**read as ACUITE triple B**) and short term rating of '**ACUITE A3+ (read as ACUITE A three plus)**' from long-term rating of '**ACUITE BBB+**' (**read as ACUITE triple B plus**) and short term rating of '**ACUITE A2 (read as ACUITE A two)**' on the Rs.14.93 crore bank facilities of Lonestar Industries (LI). This rating is now an indicative rating and is based on best available information.

**Non-cooperation by the issuer/borrower:** Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
