Acuite has reviewed the long-term rating of '**ACUITE B+** (read as **ACUITE B plus**)' and short term rating of **ACUITE A4 (read as ACUITE A four)** on the Rs. 18.34 Crore bank facilities of Blaumann Industries Private Limited (BIPL). This rating is now an indicative rating and is based on best available information.

BIPL, established in 1994, is a Kolkata-based company engaged in the manufacture and export of quality elastics tapes and narrow fabric. The manufacturing facilities are located at West Bengal and the overall operations are managed by the Directors, Mr. Sambhu Prasad Agarwal and Mr. Vikash Agarwal.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
