Acuité has withdrawn the long term rating of '**ACUITE B+** (**read as ACUITE B plus**) and the short term rating of '**ACUITE A4** (**read as ACUITE A four**) on the Rs.18.34 Crore bank facilities of Blaumann Industries Private Limited (BIPL). The rating withdrawal is in accordance with Acuité's policy on withdrawal of rating. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

BIPL, established in 1994, is a Kolkata-based company engaged in the manufacture and export of quality elastics tapes and narrow fabric. The manufacturing facilities are located at West Bengal and the overall operations are managed by the Directors, Mr. Sambhu Prasad Agarwal and Mr. Vikash Agarwal.

Non-cooperation by the issuer/borrower: Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
