Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) and the short term rating of 'ACUITE D' (Read as ACUITE D) on the Rs. 34.56 crore bank facilities of Kavcon Engineers Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Kavcon Engineers Private Limited was reconstituted as a private limited company and was given its current name (initially Kaveri Constructions) in October 2002. Kavcon Engineers Private Limited is Bangalore based company, engaged in the process of fabrication and/or galvanization of power transmission and telecommunication towers, used by the Indian Railways, State Electricity Boards and telecommunication companies. Mr. Manmohan Chopra & Mr. Govind Chopra Gopal are the directors of the company.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
