Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B-' (read as ACUITE B minus)** from '**ACUITE B' (read as ACUITE B)** on the Rs. 25.00 crore bank facilities of Vainateya Build Private Limited (VBPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Vainateya Build Private Limited (VBPL), incorporated in 2013, is a Pune-based company engaged in the construction of residential apartments and development of the commercial and rental property. The company was promoted by Mr. Vijay Arvind Raykar, Mr. Shrikant V Shete and Mr. Kalidas G Ambavale, Directors, who possess around 15 years of experience in the real estate industry.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
