# Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.11.83 crore bank facilities of NKB Extrusions Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

# **About the Company**

Based in Kolkata, NKB Extrusions Private Limited (NEPL), part of the NKB group was incorporated in 2005. Mr. Nirmal Kumar Bagaria, Mr. Nikuni Bagaria, Mr. Nalin Bagaria are directors of the company. The company commenced operations in 2012 with the manufacturing of HDPE woven sacks, HDPE Tarpaulin and other products used for packaging pesticides, fertilisers, cement, food grains, to name a few. The factory is located at Budge Budge, Kolkata.
