Acuite has downgraded the long term rating to '**ACUITE BB-**' (read as **ACUITE double B minus**) from '**ACUITE BB**' (read as **ACUITE double B**) and reviewed the short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.7.00 Cr bank facilities of VR Coatings Private Limited (VRPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

VRPL was incorporated in 1985 by Mr. D'Souza and family. The Pune based company, led by Mr. Vincent D'Souza (Managing Director), is engaged in the manufacturing of pneumatically driven airless spray painting and dispensing equipment.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
