### Rating Rationale

Acuité has reaffirmed the long term rating of 'ACUITE BB-' (read as ACUITE double B Minus) and the short-term rating of 'ACUITE A4+' (read as ACUITE A four Plus) on the Rs. 7.00 crore bank facilities of V R Coatings Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### **About the Company**

V R Coatings Private Limited was incorporated in 1985 by Mr. D'Souza and family. The Pune based company, led by Mr. Vincent D'Souza (Managing Director), is engaged in the manufacturing of pneumatically driven airless spray painting and dispensing equipment.

### **Unsupported Rating**

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
