## Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 18.00 crore bank facilities of Venkateshwara Sponge & Iron Co Private Limited (VSPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

## About the Company

Incorporated in 2005, the Jharkhand-based Venkateshwara Sponge & Iron Co Private Limited was promoted by Mr. Birendra Rai and his son to manufacture sponge iron and trade in coal. The company has an installed capacity of 100 MT per. The present directors of the company are Mr. Saurabh Kumar and Mr. Kumar Vikram Singh.

## Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
