Acuité has reviewed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) to the Rs.11.00 crore bank facilities of Ravindra Hatcheries (RH). This rating is now an indicative rating and is based on best available information.

The Haryana-based Ravindra Group, established in 2009 by Mr. Vikram Singh and Mr. Ravindra Kumar undertakes breeding and selling of broiler birds as well as manufacturing of poultry feed.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
