Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating to '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 15.69 crore bank facilities of Jai Durga Iron Private Limited (JD IPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Incorporated in 2003, Jai Durga Iron Private Limited (JD IPL) is engaged in manufacturing of sponge iron and mild steel ingots based at Jhumri Teliya (Jharkhand). The Company has its manufacturing units with an installed capacity of 48000 MTPA for sponge Iron and 16500 MTPA for mild steel ingots. The company is promoted by Mr. Binod Kumar Bajaj and Mr. Krishna Kumar Agarwal. Currently, the business is managed by the promoters and the second generation of the Bajaj and Agarwal family.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
