SMERA has reviewed long-term rating of '**SMERA D**' (read as SMERA D) on the Rs. 42.75 crore bank facilities of ANNAM STEELS (AS). This rating is now an indicative rating and is based on best available information.

#### Non-cooperation by the issuer/borrower

SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

#### About the Rated Entity

Annam Steels (AS) established in 1990, is a Chennai - based partnership firm promoted by Mr. Vijayakumar. The firm is a scrap dealer, and is currently engaged in the process of dismantling of plants and selling of scrap from NGEF Ltd.

In FY 2014-15, the firm reported profit after tax (PAT) of Rs.0.56 crore on operating income of Rs.35.90 crore against PAT of Rs. 0.55 crore on operating income of Rs. 39.57 crore for FY2013-14. The Firm's networth stands at Rs. 10.61 crore as on 31st March 2015 as compared with Rs. 8.68 crore a year earlier.
