Rating Rationale

Acuite has reaffirmed its long term rating to '**ACUITE D (read as ACUITE D)**' and the short term rating to '**ACUITE D (read as ACUITE D)**' on the Rs.27.33 crore bank facilities of Shreebhav Polyknits Private Limited (SPPL). The rating continues to be flagged as "Issue Not-Cooperating".

About the Company

Shreebhav Polyknits Private Limited (SPPL) was incorporated and promoted by Mr. Sanjay Agarwal and Mrs. Shalini Agarwal in 2002 for the manufacture of twisted yarn and knitted fabrics, Polyester grey fabric and embroidery fabric. The company has its manufacturing facilities located in Surat, Gujarat.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuite endeavored to gather information about the entity / industry from the public domain.
