Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 13.50 crore bank facilities of C.M. Roy Construction Private Limited (CMRPL). This rating is now an indicative rating and is based on the best available information.

C. M. Roy was established as a proprietorship concern in 1990 by Mr. C. M. Roy and subsequently converted into a closely held company in 2013 with the induction of Mrs. Daisy Roy and the name was changed to C M Roy Construction Private Limited (CMRPL). The company undertakes civil construction work for Andaman Public Works Department (APWD) since inception.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
