Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 13.50 crore bank facilities of C M Roy Construction Private Limited (CMRCPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

C M Roy Construction Private Limited (CMRCPL) was established as a proprietorship concern in 1990 by Mr. C M Roy and subsequently converted into a closely held company in 2013 with the induction of Mrs. Daisy Roy and the name was changed to C M Roy Construction Private Limited (CMRPL). The company undertakes civil construction work for Andaman Public Works Department (APWD) since inception. The registered office of the company is in Port Blair.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
