Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 34.68 crore bank facilities of Bhagwati Rice Mills. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Bhagwati Rice Mills was incorporated as a partnership in the year 1994 by Mr. Ajay Kumar, Mr. Vijay Kumar, and Mr. Krishna Rani. BRM is involved in basmati rice milling and is based out of Nissing, Karnal, and Haryana. It is primarily engaged in the milling and processing of basmati rice.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
