SMERA has suspended the long term rating of '**SMERA BB**' (read as **SMERA double B**) and short term rating of '**SMERA A4+**' (read as **SMERA A four plus**) assigned to the above mentioned facilities of Wevin Private Limited (WPL). The suspension follows SMERA's inability to undertake rating surveillance in the absence of requisite information from the company.

As per SMERA's suspension policy, outstanding ratings may be suspended in case of insufficient information to assess such ratings during the surveillance process.

About the Company

WPL was incorporated in 1994 as a joint venture between Jervis B. Webb Company, USA (JBW) and Vinar Systems Pvt. Ltd., India. The company is engaged in the integration of chain and non-chain conveyor systems used as a key material handling solution. The company also provides repair and maintenance services for the same.

In FY2014-15, the company achieved PAT of Rs.1.00 crore on operating income of Rs.54.85 crore as compared to PAT of Rs.0.82 crore on operating income of Rs.37.87 crore a year earlier. The net worth of the company stood at Rs.25.51 crore in FY2013-14 as compared to Rs.25.04 crore a year earlier.
