Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE Da**) and short-term rating of ‘**ACUITE D**’ (read as **ACUITE Do**) on the Rs. 25.18 crore bank facilities of Minaxi Textiles Limited (MTL). The rating continues to be flagged as “Issuer Not Co-operating” and is based on the best available information.

About the Company

Gujarat based - Incorporated in 1995, Minaxi Textiles Limited, promoted by Mr. Bharat Patel and family is engaged in the manufacturing of grey cloth used in suiting and shirting.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
