Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE Da) nd short-term rating of 'ACUITE D' (read as ACUITE Do) n the Rs. 25.18 crore bank facilities of Minaxi Textiles Limited (MTL). The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

Gujarat based - Incorporated in 1995, Minaxi Textiles Limited, promoted by Mr. Bharat Patel and family is engaged in the manufacturing of grey cloth used in suiting and shirting.

Non-cooperation by the issuer/borrower:
