Rating Rationale

Acuité has downgraded the long term rating to '**ACUITE B-' (read as ACUITE B minus)** from '**ACUITE B' (read as ACUITE B)** on the Rs.10.00 Cr. bank facilities of MDH Motors Private Limited (MMPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

The Andhra Pradesh-based MDH Motors Private Limited (MMPL), established in 2011 by Mr. Mohammed Naveed Shaik is an authorized dealer of passenger vehicles for Hyundai Motors. The company also undertakes servicing of vehicles and deals in spare parts. MMPL has one 3S (sales-service-spares) facility in Andhra Pradesh.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
