Rating Rationale

Acuite has downgraded the long-term rating to ‘**ACUITE B-**’ (read as **ACUITE B minus**) from ‘**ACUITE B**’ (read as **ACUITE B**) on the Rs. 9.12 crore-bank facilities of Mohanlal Shankarlal Agro Foods Private Limited on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Nagpur-based, Mohanlal Shankarlal Agro Foods Private Limited was incorporated in 2013 by Late Mr. Shankarlal Mohanlal Agarwal, Mr. Sunil Agarwal and Mr. Sumeet Agarwal. The company belongs to Chakradhar group of companies and is engaged in processing and sorting of Basmati and Non-Basmati rice. The company owns two rice mills having installed capacity of 8MTPH each and one small unit for processing. The company has its own brand name “Kashmiri Kesar”. The commercial operations started in April 2017.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
