Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 5.75 Cr. bank facilities of Bijasani Ginning And Pressing Factory (BGPF). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Bijasani Ginning And Pressing Factory is a Jalgaon-based partnership firm established in 2008 by Mr. Sanjay Choudhary and Mr. Umesh Choudhary. The firm is engaged in the ginning and pressing of cotton.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
