**Rating Rationale**

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 30.00 crore bank facilities of Pankaj Automobiles Private Limited (PAPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

**About the Company**

The Punjab-based Pankaj Automobiles Private Limited (PAPL), established in 2012, was an authorised dealer of Maruti Suzuki India Limited with showroom and service centre in Punjab. The company also undertook sale of second hand cars through the True Value Channel. However, the company has surrendered the dealership of MSIL on March 2016. Directors of the company are Pankaj Bansal, Dawarka Nath Bansal and Rajat Bansal.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
