Acuite has downgraded the long term rating to '**ACUITE BB**' (read as **ACUITE double B**) from '**ACUITE BB+**' (read as **ACUITE double B plus**) and the short term rating to '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 31.73 crore bank facilities of C.P Re-Rollers Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

CPRL, incorporated in 2000, is engaged in the manufacturing of ingots, TMT bars and structural steel products (MS rounds, angles and channels). The company was promoted by Mr. Kumar Chand Chawla and Mr. Dilip Chawla.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
