### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B+' (read as ACUITE B plus) from 'ACUITE BB-' (read as ACUITE double B minus) and the short-term rating of 'ACUITE A4' (read as ACUITE A four) from 'ACUITE A4+' (read as ACUITE A four plus) on the Rs. 31.73 crore bank facilities of C.P. Re-Rollers Limited (CPRL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

### **About the Company**

C.P Re-Rollers Limited (CPRL), incorporated in 2000, is engaged in the manufacturing of ingots, TMT bars and structural steel products (MS rounds, angles and channels). Based in West Bengal, the company was promoted by Mr. Kumar Chand Chawla and Mr. Dilip Chawla.

### **Unsupported Rating**

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
