**Rating Rationale**

Acuite has downgraded the long-term rating to ‘**ACUITE C**’ (read as **ACUITE C**) from ‘**ACUITE B+**’ (read as **ACUITE B plus**) on the Rs. 15.00 crore bank facilities of Singla Motors Private Limited (SMPL). The rating continues to be flagged as Issuer Not Cooperating and is *based on best available information*.

The downgrade is based on information reflected in the Credit Information Bureau (CIB) report, which shows recent delays in repayment of multiple long-term loan accounts in the month of December 2024.

**About the Company**

Singla Motors Private Limited (SMPL), incorporated in 2011 and promoted by Mr. Virender Kumar, is a Haryana-based company that manufactures submersible, monoblock pumps, motors stainless steel submersible and AC induction motors used in the agricultural sector, households and industrial segments.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

**Limitation regarding information availability**

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management interaction with the issuer entity or any data / information from the entity. Sometimes this non co-operation by a rated entity may be due to a result of deterioration in the credit risk profile of the entity.
