**Rating Rationale**

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE Do**) n the Rs. 8.35 crore bank facilities of Bhagyalaxmi. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

**About the Company**

Bhagyalaxmi is engaged in the development of real estate at Surat (Gujarat) by Mr. Trushar Patel and established in 1993. The first venture of the firm, Bhagyalaxmi Residency project consists of six low rise residential buildings comprising 394 flats with built-up area of 1,59,827.79 sq. ft. and saleable area of 2,31,000 sq. ft. on land admeasuring 6824.19 sq. mtrs.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
