Rating Rationale

Acuité has Reaffirmed the long term rating of 'ACUITE D' (read as ACUITE D) and short term rating of 'ACUITE D' (read as ACUITE D) on the Rs.10.98 Cr bank facilities of ABC Garments. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Tamil Nadu based ABC Garments is established in 1993 is a partnership firm engaged in the manufacturing and export of readymade garments for men, women and kids. The firm exports its products to Europe, USA, among others. The firm is headed Mr. R Annadurai, Partner, who possesses experience of over two decades in the business.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
