Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) and the short-term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 310.04 crore bank facilities of Wearit Global Limited (WGL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Kolkata based Wearit Global Limited (the erstwhile Ritspin Global Limited), incorporated in 1999 as an investment company and changed its business to trading in polyester yarns and fibres in 2002. The company started with manufacturing activities from FY 2011 with the acquisition of a spinning unit which had installed capacities of 25,776 spindles. The company had a combined installed capacity of 1,55,648 spindles and is managed by Mr. Manish Kumar, Mr. Sandeep Agarwal and Mr. Manas Ghosal.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
