**Rating Rationale**

Acuite has reaffirmed the long-term rating of '**ACUITE B-' (read as ACUITE B minus)** on the Rs. 7.64 crore bank facilities of Golden Falcon India Private Limited (GFIPL). The rating continues to be flagged as "Issuer NotCooperating" and is based on the best available information.

**About the Company**

Golden Falcon India Private Limited, incorporated in 2007, is a Surat-based company promoted by Mr. Paresh Jariwala and Mr. Pratik Jariwala. The company is engaged in the manufacture of knitted fabrics and trading of embroidery machines and has set up a facility to manufacture knitted garments in Surat. The commercial operations commenced from February 2015.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
