Rating Rationale

Acuité has reaffirmed the long-term rating of **'ACUITE D'** (read as ACUITE D)on the Rs. 6.50 crore bank facilities of Sreeven Pharma Private Limited (SPPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Sreeven Pharma Private Limited, a Hyderabad-based company was established in 2003 by Mr. Devendrappa J K. The company, a bulk drug manufacturer plans to enter into manufacturing of pharmaceuticals formulations (tablets, liquid orals, ointments etc.) by setting up a WHO & cGMP (Current Good Manufacturing Practices) certified facility.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
