Rating Rationale

Acuité has reaffirmed the long-term rating to 'ACUITE B+' (read as ACUITE single B plus) and the short term rating to 'ACUITE A4' (read as ACUITE A four)' on the Rs. 24.00 crore bank facilities of Komal Exotic Spices Private Limited (KESPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is reaffirmed on account of information risk.

About the Company

KESPL, incorporated in 2009, is a Mumbai-based company engaged in the import, processing and trading of spices such as cloves, black pepper, cumin seeds and cinnamon. The company is promoted by Mr. Gopaal Ahuja and family. The company's head office is located at The Mumbai Agricultural Produce Market (APMC) at Vashi - Asia's largest regulated market for agricultural produce. The company has two godown-cumprocessing facilities located within the market wherein it carries out cleaning, sorting, grading and packing of spices. The company procures around 40 percent of its material from Sri Lanka, Indonesia and Africa, among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
