Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) and reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 24.00 crore bank facilities of Komal Exotic Spices Private Limited (KESPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Komal Exotic Spices Private Limited (KESPL), incorporated in 2009, is a Mumbai-based company engaged in the import, processing and trading of spices such as cloves, black pepper, cumin seeds and cinnamon. The company is promoted by Mr. Gopaal Ahuja and family. The company's head office is located at The Mumbai Agricultural Produce Market (APMC) at Vashi - Asia's largest regulated market for agricultural produce. The company has two godown-cum processing facilities located within the market wherein it carries out cleaning, sorting, grading and packing of spices. The company procures around 40 percent of its material from Sri Lanka, Indonesia and Africa, among others.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
