Acuite has downgraded the long term rating to '**ACUITE D**' (read as **ACUITE D**) from '**ACUITE B**' (read as **ACUITE B**) and the short term rating to '**ACUITE D**' (read as **ACUITE D**) from '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.12.50 crore bank facilities of Surya & Company. This rating is now an indicative rating and is based on best available information.

The downgrade is in view of persistent delays in servicing the debt obligation.

Established in 1990 by Mr. Sudesh Tanwar, Surya & Company is a Delhi based proprietorship firm engaged in undertaking electrical and civil contracts such as construction of sub-stations, laying of feeder lines and roads. The firm has an associate concern, namely, Parkash & Company which is also engaged in similar line of business.

#### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
