Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B' (read as ACUITE B) and the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 20.00 crore bank facilities of Bhagya Laxmi Gems and Jewellers Private Limited (BLGJ). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Bhagya Laxmi Gems and Jewellers Private Limited (BLGJ), was established as a proprietorship concern and in the year 2010. It converted into private limited. It is a Hyderabad based company engaged into manufacturing and wholesale trading of gold jewellery. Bhagyalaxmi has gold jewellery showrooms in Hyderabad, Mumbai, and Chennai. Mr. Kunal Gupta and Ms. Shilpa Agarwal are the directors of the company since its incorporation.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain.
