SMERA has assigned a long-term rating of '**SMERA BB**' (read as **SMERA double B**) and a short-term rating of '**SMERA A4+**' (read as **SMERA A four plus**) to the Rs.12.31 crore bank facilities of Adinath Industries (AI). The outlook is '**Stable**'. To arrive at the ratings, SMERA has combined the business and financial risk profiles of AI and Parasnath Enterprises, together referred to as the 'AIPE Group'. The consolidation is in view of the common business models of the entities. The ratings are supported by the group's established operations, experienced management and moderate financial risk profile. However, the ratings are constrained by the working capital intensive nature of business and intense competition prevalent in the rubber and plastic industry. The ratings also note the company's tender based business.

Outlook: Stable

SMERA believes the AIPE Group will maintain a stable business risk profile over the medium term. The group will continue to benefit from its established operations and experienced management. The outlook may be revised to 'Positive' in case the company registers healthy growth in revenues and profits while maintaining debt protection metrics. The outlook may be revised to 'Negative' in case of deterioration in the firm's financial risk profile or stretch in the company's working capital cycle.
