Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs.8.00 crore bank facilities of Sri Mallikarjuna Industries (SMI). This rating is now an indicative rating and is based on best available information.
