Acuité has reviewed the long-term rating of '**ACUITE BB+**' (read as **ACUITE double B plus**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.25.00 crore bank facilities of Bhumi Procon Private Limited (BPPL). This rating is now an indicative rating and is based on best available information.

BPPL is a Vadodara-based civil construction company. The company was established as a partnership firm under the name of 'Bhumi Constructions' and later in the year 2013, was converted to private limited company. The Directors are Mr. Sanjay A. Sanghavi and Mr. Alkesh J. Shah.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
