Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs.50.00 crore bank facilities of Aashiyana Promoters & Developers Private Limited (APDPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Aashiyana Promoters & Developers Private Limited (APDPL), established in 2007, is a Special Purpose Vehicle (SPV) of the Delhi-based Newtech Group. The company has undertaken the construction of a group housing complex in Gautam Budh Nagar, Uttar Pradesh. Mr. Harsh Nagar and Ms. Manisha are the promoters.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
