Acuite has reviewed long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) 'on the Rs.8.56 crore bank facilities of Vpc and Co. This rating is now an indicative rating and is based on best available information.

VPC and Co was established as partnership firm in 2004 by Mr. V.P. Chettyannan and Mr. R. Ramesh. At present, Mr. R. Ramesh, Mrs. R. Kalaivani and Mr. S.K. Pugazenthi are the current partners of the firm. The Firm is engaged in trading of scrap metals (ferrous and non-ferrous).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
